To: Potential Recruit Candidates

The Ammon Fire Department is a combination department consisting of 40 paid-call firefighters (also called compensated volunteers) and three full-time firefighters. We hire for the paid-call positions each year. There are four requirements you must meet to be considered for paid-call firefighter:

- You must be at least 18 years of age;
- You must possess a valid driver's license;
- You must live within ten minutes of the Ammon Fire Station, 2135 S Ammon Road;
- Persons having been convicted of abuse, any sexual based crime or felony shall not be considered.

The process to become an Ammon Firefighter consists of five phases; an applicant must pass/meet all requirements of each required phase to advance to the next phase:

- ➤ Phase 1 Complete and return the Application Packet by the stated deadline;
- ➤ Phase 2 Background checks on all applicants, applicants that are disqualified will be notified;
- ➤ Phase 3 Successfully complete the Ammon Fire Department Physical Agility Test as outlined in this packet;
- ➤ Phase 4 Successfully complete the Ammon Fire Department Entry Level Written Test;
- ➤ Phase 5 Attend an Oral Interview:
 - o Applicants are ranked on their interview score.

Once an Applicant is hired they are considered a Recruit; all Recruits are required to complete IFSAC FF I Certification, Hazardous Materials Operations and Wildland Fire Certification in the first year. IFSAC accreditation training lasts for approximately six months; classes are every Tuesday and Thursday from 1800-2200 hours and one Saturday per month from 0800-1700 hours. All chapter tests must be completed by set deadlines, if a Recruit misses a class we require them to schedule make-up dates to keep them current. A Recruit missing more than half of the scheduled classes will be dismissed from the department.

We utilize a two battalion system, each Firefighter is placed on a Battalion, issued a pager and are compensated at a set rate per call they attend, when they have been trained to the minimum level.

We compensate Recruits at \$100.00 per month; Once a Recruit completes their IFSAC FF I accreditation they are considered a Firefighter; All Firefighters are required to attend a minimum of 75% of all regular scheduled training provided, which equates to nine hours per month (after the FF I class is completed) to be eligible for monthly compensation.

If you are interested in a paid-call position with our Department, please fill out the application packet and return it to the Ammon City Offices by the deadline.
