

City of Ammon 2025 General Election Information

GENERAL ELECTION DATE: Tuesday – November 4, 2025

SEATS UP FOR ELECTION:

Three City Council Seats (Seats #2, #4, #6) and the Mayor seat

INCUMBENTS: The incumbents whose terms will expire as City Council Members in 2025:

Seat #2: Russell Slack Seat #4: Kris Oswald Seat #6: Sid Hamberlin Mayor: Sean Coletti

QUALIFICATIONS TO RUN FOR CITY OFFICE:

The candidate must be at least 18 years of age
The candidate must be a U.S. citizen
The candidate's primary residence must be in the City of Ammon.
The candidate must be registered to vote, and the address of the candidate's voter registration must match the residence address provided on the candidate's declaration.
The candidate must have resided in Ammon City limits for at least 30 days prior to submitting their declaration

CANDIDATES: Any <u>qualified elector</u> living within the City Limits of Ammon may become a candidate in two ways:

- 1. By submitting their Declaration of Candidacy along with the Petition of Candidacy form signed by not less than five (5) qualified electors; or
- 2. By submitting their Declaration of Candidacy along with a nonrefundable filing fee of forty dollars (\$40).

A candidate may also submit a Declaration of Intent for Write-in Candidates, as provided in Idaho Code § 34-702A.

CANDIDATE FILING PERIOD: The period for a candidate to file their Declaration of Candidacy and Petition (or \$40) is between <u>8:00 a.m. on Monday, August 18, 2025 and 5:00 p.m. on Friday, August 29, 2025</u>. No applications will be accepted after 5:00pm on August 29, 2025.

<u>IMPORTANT:</u> The Idaho Code makes it clear that candidates are responsible for having petition signatures verified by the County Clerk (Elections Office at 497 N Capital Ave Idaho Falls, ID 83402) <u>before</u> submitting a Petition of Candidacy to the City Clerk by the prescribed deadline. Also, please note that the Declaration of Candidacy and the Petition of Candidacy must be notarized prior to submitting them to the County Elections Office for verification.

CAMPAIGN FINANCE DISCLOSURE INFORMATION: All candidates are required to appoint a treasurer once he/she has raised or spent \$500 with the Idaho Secretary of State's Office. Additional Information That May Be Helpful:

WHAT IS THE TIME COMMITMENT OF AN ELECTED CITY COUNCIL MEMBER: Council Members are expected to attend all City Council Meetings – currently held at 6:00pm on the first and third Thursday of each month, and at 4:30pm on the second Thursday of each month. Council Members are expected to spend some time preparing themselves for public meetings by reviewing materials provided by City Staff. Council Members may also be asked to serve on local boards and committees.

EMPLOYMENT STATUS: The salary of elected officials is set by ordinance. The Mayor and each Council Member shall receive a biweekly stipend and benefit packages for insurance are available including health, dental, vision, life, and PERSI retirement, during his/her term of office.

ELECTION CAMPAIGN SIGNS: Political signs may be posted up to <u>60 days prior to an election</u> and must be <u>removed within 10 days following the election</u>. Signs may be placed on private property with permission of the land owner but CANNOT be placed within any public right-of-way areas. For more information, refer to the Ammon Sign Code within Title 10, Chapter 34. (Also see Idaho Code 18-7209)

ARE YOU A RESIDENT OF AMMON?: You can check your residency in a few simple ways. Do you pay any utility bills to the City of Ammon? If yes, you are a resident. The Clerk's Office also has a subdivision map you can check while you pick up your application.

Filing Dates and Deadlines

You must submit your complete declaration of candidacy plus the petitions by 5:00 pm (local time) on the last day of the candidate filing period. (§50-410, Idaho Code)

All deadlines are at 5:00 pm (local time).

Candidate Filing Period

Filing Begins: August 18, 2025 Filing Ends: August 29, 2025

Withdrawal Deadline

September 5, 2025

The Clerk of the Political District must notify the county within 24 hours of a filing (§34-1404, Idaho Code)

Filing Options

Candidates for city office have two options when filing for placement on the ballot:

1. Pay the filing fee

City Office: \$40.00 filing fee

Or

2. Submit nominating petitions

City Office: 5 valid signatures of eligible voters within the city

Completing the Declaration of Candidacy

When completing the Declaration of Candidacy, be sure to complete all fields and questions. Any incomplete or missing information may void your filing.

Section 1: Office Information

Enter the name of the office you are running for, then enter the name of the city in which you are running.

Section 2: Candidate Information

When entering your Ballot Name, the following will <u>NOT</u> be allowed on the ballot:

- Nicknames that promote a particular political platform or are deemed offensive.
- Professional or military identifiers such as Dr.,
 M.D., PhD., Esq., CPA, Captain, General, etc.

A phone number and email address are both required and will become publicly available upon request.

Section 3: Registered Address

- This <u>MUST</u> be a physical address. P.O. Boxes will not be accepted.
- If your registered address is the same as your mailing address, check the box at the bottom of this section and skip section 4.

Section 4: Mailing Address

- P.O. Boxes are acceptable.
- If your mailing address is the same as your registered address, check the box at the bottom of section 3 and leave this section blank.

Section 5: Homeowner's Exemption

If you or your spouse have claimed a Homeowner's exemption, list the address in this section.

Section 6: Campaign Finance

If your campaign finance contributions or expenditures exceed \$500, you **MUST** create a campaign finance account with the Idaho Secretary of State.
